Editorial Policy

The purpose of the site is to publish articles and get feedback from readers on key points in the articles called Takeaways. Writers will have rights for the content they can write, which will be set up by the administrator. Articles should be concise and the Takeaways should be well thought out. If too many readers select abstain, it may indicate that the article or the Takeaway is not clear. Along with the rights, the writer has responsibilities which are defined in the Terms and Conditions of the site. They are part of what the writer agrees to in order to post articles on the site.

Writing: All content shall be unbiased and based on facts. All information must be verifiable. Write clearly, concisely and draw a conclusion. Use the pyramid style of writing by placing the most important information first. Write in short sentences when possible. Identify and write to your primary audience. Write in a conversational style with easy to understand language. It should be free of spelling errors and grammatically correct.

Writer's Rights: Writer's can write to any content category, also know as a filter, they have rights to. Writers will be given rights to post content by the site administrator. The writer's rights define the categories the writer can write in. Content categories are sections targeted to a specific interest, such as Politics or Sports. Writers can be given rights to one or more content category.

Content Types: There are three types of content: Takes, articles, and long articles. Takes consist of just Takeaways without an article. Articles are limited to 300 words. Long articles are limited to 500-800 words. However, our main intent is to have 300 word articles.

Content Rules

- **Headline Guidelines**: Headlines are limited to 70 characters. Headlines are the most important piece of text on the page and should summarize the content clearly and concisely. To prepare for writing the headline, do the following: review the content; identify the point of the content; list three to six keywords that should be in the headline, such as proper nouns, that readers would use in a search to find the article; use a strong verb to convey meaning. Be careful to not repeat a sentence from the article. When possible, the headline can correspond to one of the Takeaways.
- T1's: T1's consist of just one Takeaways and an article of up to 60 words. The topics of the Takes should be from current events that do not need much explanation. Takes shall include an image.
- Regular Article: Regular articles should be concise and are limited to 300 words. They should also relate to the category that they are to be published in. For example, if a writer has the right to write articles about politics, it should be about politics and not about sports. The post shall also include an image or a video link with an image.
- Takeaway Guidelines: Takeaways should be statements that the reader can agree, disagree, or abstain. A Takeaway should be a statement taken from the article or at least derived from a statement



in the article. Articles can have up to four Takeaways. Takes only have up to three Takeaways. An abstain vote is an option to show that the Takeaway may need more explanation in the article.

- Social Media, Twitter, etc: The writer will be responsible for writing Twitter tweets with hashtags.
- **Supporting Articles**: When writing an article that refers to one or more articles published elsewhere, consider the following:
 - Paraphrase and recast the article to avoid plagiarism. When paraphrasing, make sure to retain the essential points and arguments of the other article and avoid taking anything in the other article out of context.
 - When quoting the text verbatim, enclose the quote with quotation marks. Frame the quoted material by writing a sentence before and after the quote to setup and support the quote. Make sure to give the author name and publication it appeared in (and make the publication a link to the article).
 - Add a link at the end of each topic for the original article when the topic refers to one article.

How to Become a Writer for OPandGO:

- All requests for writer privileges will generally be responded to with a request for writing samples.
 Develop a basic portfolio of work that you're proud of and be ready to submit it (a link will suffice).
- Please provide a brief explanation on your subject matter expertise for Filter qualification. A Filter is a content category such as politics or sports.
- Provide a brief description of your current audience (if any).
- Writers must agree to our Content, Style and Sizing Rules.
- Writers must agree to our Terms & Conditions
- Writers must adhere to our Login Procedures (see next section)

First Post: Before your first post, login to the website for the first time and set up your account with your name, email, etc. Write a short two to three sentence bio and have a headshot photo available for upload (jpg preferred). Also have other information ready to be entered, such as the address for your personal website, your blog address, or Twitter handle.

Revenue Sharing: Revenue sharing is based on two sources of revenue. One is advertising and the other is any other site revenue. Writers will receive 1/3 of the ad revenue for their article pages (unique views). All other site revenue and other non-direct ad revenue will be distributed 1/3 to the writers based on a formula of percent page views for each writer. (For example is the writer's articles receive 5% of all page views on the site, they will receive %5 of 1/3 of the other revenue.) If the terms of the revenue sharing should change in the future, these terms will be grandfathered in for writers that have accepted these terms. Other revenue is defined as ad revenue from general pages and site subscriptions. Compensation will be given to writers for ad revenue on their article pages that are current and active, and for other revenue for writers who have posted articles in the last 120 days. Exclusion: Revenue sharing with writers does not include the sale of all or any part of the company in the future. In such event, there is no



guarantee that the future owners will abide by this clause.

OPandGO Contributor Login and Content Posting

In summary, to post a topic, the following fields need to be filled in:

To Begin:

Login to OPandGO.com: Go to OPandGO.com. In the upper right of the screen, click on Login or Register.

Topic Input Screen: After you have logged in, there is now an addition black bar at the top of the screen. At the top, go to OPandGO/Dashboard. From the Dashboard screen, on the left, go to Topics/Add Topics. You are now at the article input screen.

Left side of the input screen

(For content guidelines on the specific article components listed below, please refer to the Writers Kit.) **Headline:** Input the headline in initial caps (not all caps). Headlines are limited to 70 characters.

Topic Copy: Input the main copy for the topic. Topic copy is limited to 300 words. Please do not add indents for paragraphs or double spaces between sentences. Leave this blank section blank if you are inputting a "T1" which has one Takeaway and 60 words or less (input the copy into the Summary).

Summary: Input a short topic summary of one to two sentences. The summary is limited to 60 words. (This will appear below the headline and above the topic copy when published on the website.)



Takeaways: There is one line available for the first Takeaway. To add more, click on Add Takeaway. You can input up to 3 Takeaways for users to give their opinion on. Takeaways should be entered as statements for users to agree or disagree with (not questions).

Tweet: Input copy that will be automatically posted to a Twitter account. Tweets should be about 100 characters to allow for topic link and retweeting. (Twitter has 140 character limit)

Email Teaser Copy: Input Email Teaser Copy. Teaser copy is limited to 70 characters. This is meant to generate interest and get the user to click on the link in the email sent to users. It can be a question. (For example: Headline - World Leaders Meet; Teaser: Will the fighting stop?)

Featured Image: The contributor must add an image and image credit for each topic they post. Adding an image is a three step process.

First, find the image you want and put it on your computer if it's not already there. If you are downloading from the internet, it is easiest to put it on your desktop. It should be saved as a jpg image. Make note of the image credit as you will need it later. (For stock photography or on Wikipedia, the image credit will be given. Also, make sure you have the right to use the image or, in the case of Wikipedia, that the image is either in the public domain or uses a Creative Commons licensing agreement.)

Second, click on Set Featured Image. A Media Library window will open. Drag and drop your image from your desktop to this window. In the Media Library window, make sure your image is selected on the left part of the screen and then check the text fields on the right. In the Caption field, input the image credit (for example: BobsPhotos/Wikipedia). When done, select Set Featured Image button in the bottom right.

Right side of the input screen:

Expiration/Polls Closed Dates: Input dates for Expiration and Polls Closed. They can be the same. If different, Polls Closed should end before Expiration.

Categories: Select the section within which the topic will be published.

Tags/Descriptors: Input tag or tags which will show up on the homepage next to the topic. Use 2–3 tags.

Additional:

Demographics: If your topic requires specific demographics, select them here to make sure the user will be prompted to input the selected information if it is not in their profile.



Publish

Save as Draft/Publish: At the top right of the screen, go to the Publish box. Click Save Draft if you are not finished and want to return to it later. Click Preview to see how it will look when published on the site.

The topic can be scheduled to be published later by editing Publish which is above Expiration. At the bottom of the box, click Publish or Save for Review depending on what is available to you.

To check topics that have been published, go to OPandGO/Visit Site in the upper left.
